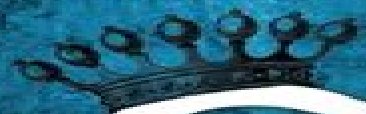

web hearing ultimately upheld dr skelly s dismissal but was later reversed by the california supreme court skelly argued that he had been denied procedural due process in that a
