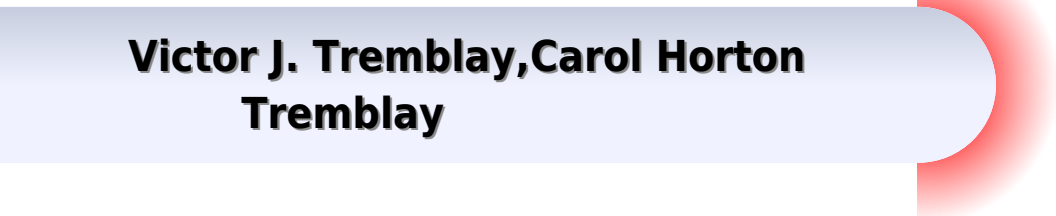

Recognizing this difficulty we provide new insights on evaluation of third degree price discrimination in consideration of network effects and vertical product differentiation. Furthermore we also study the welfare effects of third degree price discrimination under imperfect competition other than monopoly.
