ABSTRACT

The internal system of substantive commercial law is the scientific understanding of the essence of commercial law and its internal objective law, which exists after the system of positive law such as rules and principles of commercial law, and is the soul and spirit of commercial law and sectoral law, and also the fundamental driving force of commercial law research [1].
